NOTE- Income of the purpose of Means Test is defined as under:-

(a) In the case of salaried class, full emoluments including all allowances, honorarium, bonus, special pay etc. (exclusive of HRR, if any) received in a year shall be taken into account for computing annual income. A standard deduction @30% subject to maximum of Rs.10,000/- will be allowed on gross income. No relief for long term savings: contribution to Provident Fund, Life Insurance etc. will be allowed.

(b) In case of non-salaried class such as businessman, land owners / agriculturists and self-employed etc. on standard deduction will be allowed and their entire gross Income will be taken into consideration for computing their annual income.

(c) In the case of pensioners the income will also be computed as provision of (h) above.

- EXPLANATION:-I**
- (1) Total income of the family should include income only of father and mother and the scholar and of onb other members through they may be earning.**
 - (2) If father is dead, mother's income will be shown along with the income, if any in the scholar's own name from shares, property etc.**
 - (3) If both father and mother of the scholar are deceased then the incoem if any, in the scholar's name only will be shown, and not the income of any guardian who may be supporting the scholar.**

EXPLANATION-II Income for this purpose will be determined on the basis of the annual income earned in the financial year preceding the year of the examination for which the scholarship awarded is given.
