SCOPE OF WORK

Carryout necessary study and collection of data etc. for the purpose of the work, re-demarcation of leasehold area as per cadastral maps, survey and preparation of maps, defining boundary pillar sites, DGPS or GPS as required by IBM survey & integration of associated jobs so as to ensure compliance with instructions of IBM (excluding erection of boundary pillars) and preparation & submission of each mining scheme for above mentioned capacity, getting and obtaining approval from Indian Bureau of Mines for the same. 1. CONSTITUTION

2. EXPERIENCE

Agency should have prepared at least 5 Mining Plans/Scheme during last three years i.e 2011-12, 2012-13 and 2013-14 for major mineral mines with an area of more than 5 hectares. Such plans should have been approved from IBM. Copies of approval letters from IBM shall have to be submitted.

3. REGISTRATION

The consultant must be registered as Recognised Qualified Person(RQP) with the IBM.

4. FINANCIAL TERMS & CONDITIONS

Payment to the successful bidder shall be made as under against work executed:-

No advance against the work order. 30% after submission of draft Mining Schemes as per extant guidelines/circulars to IBM, & 70% after obtaining approval from IBM for both Mining Schemes for the said mines, subject to submitting one approved Mining Scheme & its two coloured photocopies for each mine.
